**ACCEPTING GRANT FUNDS IN AN AMOUNT UP TO
\$171,600.00 FROM THE U.S. DEPARTMENT OF JUSTICE,
OFFICE OF COMMUNITY ORIENTED POLICING
SERVICES, FOR DE-ESCALATION TRAINING.**

WHEREAS, the U.S. Department of Justice (DOJ), Office of Community Oriented Policing Services (COPS), has authorized a grant in an amount up to \$171,600.00 to the San Antonio Police Department (SAPD) or training in the development of de-escalation skills; and

WHEREAS, the grant period begins September 11, 2021, and ends August 31, 2023; and

WHEREAS, the SAPD wishes to apply for said grant funds; and

WHEREAS, there is no cash or in-kind match required; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The City Manager and designee, and the Chief of Police and designee, are hereby authorized to accept grant funds in an amount not to exceed \$171,600.00 from the DOJ, COPS, for De-Escalation Training, under the same terms and conditions as applied for. The City Manager and designee, and the Chief of Police and designee, are further authorized to execute any and all documents necessary to effectuate said application and acceptance.


SECTION 2. Upon acceptance of this award, a new fund and internal order number will be created, upon which the sum of \$176,600.00 from DOJ, COPS, will be appropriated. The proposed budget attached hereto as **Exhibit A** is hereby approved. A formal budget will be provided upon acceptance of funds.

SECTION 3. The financial allocations in this Ordinance are subject to approval by the Deputy Chief Financial Officer, City of San Antonio. The Deputy Chief Financial Officer may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this Ordinance

SECTION 4. This Ordinance is effective immediately upon the receipt of eight affirmative votes; otherwise, it is effective ten days after passage.


