I. Call to Order

II. Public Comments

There was one public comment received via voicemail from Cyrus Reed, Sierra Club. "Hello, my name is Cyrus Reed, I work for the Sierra Club on research. I don't live in San Antonio but did want to leave a brief message about item number three on the Technical & Community Advisory Committee, which are the Unified Development Codes and building-related codes. I wanted to encourage the committee to move forward on three things, EV ready codes, solar ready codes, and adoption of the 2021 International Energy Conservation Code. The 2021 ICC has already been catalyzed by the energy system lab at Texas A&M and nationally as being about 10% more energy efficient. And then I wanted to highlight that myself and many



folks in San Antonio already worked with Development Services on EV ready and solar ready codes and came up with some drafts that would be a good starting place. We did this work in 2020 right before COVID happened so there's been a bit of a delay, but a lot of that work has already happened, I believe that ya'll could move forward on EV ready, solar ready, and 2021 codes, email me if you have any questions Cyrus.Reed@sierraclub.org..."

When sending to the appropriate point(s) of contact, the scorecard will be accompanied by a statement on purpose and intent. Although a position paper was initially dismissed, the group voted in support of a letter to be sent to City staff and/or elected representatives through a motion to finalize both the statement and scorecard. This letter would emphasize the need for sustainability considerations for the 2022 Bond Program and advocate for climate action to be considered earlier on in the process for all future bond programs.

UDC & Building Related Codes:



During the October Advisory Committee meeting, the committee decided to request recommendations for amendments from all members. Individual members submitted recommendations throughout the month, these were compiled by the Office of Sustainability and sent to the complete membership for review prior to the November meeting. After some discussion, Advisory Committee members requested for staff to create a survey to assist in prioritization by ranking all submissions in order of preference. These preference selections will not be an endorsement of proposals but will help staff develop more detailed information for the committee's consideration prior to making any final decisions.

Once the top recommendations are selected, Office of Sustainability staff will communicate with the Development Services Department to draft proposed language for review by the full Advisory Committee. The Advisory Committee can also choose to support partner agency proposals. The deadline for all amendment recommendations is February 1, 2022.
