

This Amendment No. 1 is entered into by and between **City of San Antonio, TX** (hereinafter referred to as "**City**") and **Environmental Systems Research Institute, Inc.** (hereinafter referred to as "**Esri**").

WHEREAS, Esri and City entered into an Enterprise License Agreement (Esri Agreement No. 00037026.0, formerly no. 332614) with an effective date of October 19, 2018 and end date of October 18, 2021 (hereinafter "Agreement"); and

WHEREAS, the parties desire to amend the Agreement to extend the term for an additional three (3) months from October 19, 2021 through January 18, 2022, and update applicable language and appendices;

NOW THEREFORE, the parties agree to the following:

- 7.1 Term. The term of the EA is hereby extended for an additional three (3) months commencing October 19, 2021 through January 18, 2022 ("Renewal Term") unless this EA is terminated earlier as provided in the Agreement. Upon full execution of this Amendment No. 1, City shall pay Esri an amount of One Hundred Seventy Thousand & Two Hundred Ninety-Five Dollars (\$170,295 USD) in consideration for the Renewal Term.
