APPROVING THE FOLLOWING CONTRACTS ESTABLISHING UNIT PRICES FOR GOODS AND SERVICES FOR AN ESTIMATED ANNUAL \$4,827,000.00, **INCLUDED** IN **OF** THE RESPECTIVE DEPARTMENT'S FY 2022 ADOPTED BUDGET: (A) HLP, INC., FOR MAINTENANCE AND SUPPORT FOR THE CHAMELEON SHELTER SOFTWARE CASE MANAGEMENT SYSTEM FOR ANIMAL CARE SERVICES; (B) GT DISTRIBUTORS, INC., AND PRECISION DELTA CORPORATION FOR AMMUNITION FOR THE SAN ANTONIO POLICE DEPARTMENT AND OTHER LAW ENFORCEMENT OFFICERS; AND (C) WEX BANK FOR A FLEET FUELING CARD SYSTEM FOR THE SAN ANTONIO FIRE DEPARTMENT.

WHEREAS, this ordinance approves contracts (A) HLP, Inc., for maintenance and support for the Chameleon Shelter Software Case Management System for Animal Care Services; (B) GT Distributors, Inc., and Precision Delta Corporation for ammunition for SAPD and other law enforcement officers; and (C) Wex Bank for a fleet fueling card system for SAFD; and

WHEREAS, the Texas Local Government Code indicates that competitive bidding is not required under section 252.022(a)(7)(A), which provides for any items that are available only from a sole source of supply; and

WHEREAS, the Texas Local Government Code indicates that competitive bidding is not required under section 252.022(a)(2), which provides for a procurement necessary to protect the public health or safety; and

WHEREAS, all expenditures will be in accordance with the applicable fiscal year's budget approved by City Council; NOW THEREFORE:

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The following bids to furnish the City with goods and services on an annual basis as shown on the attached bid tabulation sheets are hereby accepted, subject to and contingent upon the deposit of all required bonds, performance deposits, insurance certificates and endorsements: (A) HLP, Inc., for maintenance and support for the Chameleon Shelter Software Case Management System for Animal Care Services; (B) GT Distributors, Inc., and Precision Delta Corporation for ammunition for SAPD and other law enforcement officers; and (C) Wex Bank for a fleet fueling card system for SAFD.
