According to the San Antonio Housing Policy Framework report: "the gap in rental housing for households under 60 percent AMI is projected to increase from a 34,000 unit mismatch to an estimated 53,000 unit mismatch by 2030" (p. 37) I believe this gap has likely exacerbated as a result of the COVID pandemic. Housing costs continue to outpace the income of San Antonio residents and I believe the situation is actually underrepresented due to the inclusion of New Braunfels when calculating the area AMI. SA renters are disproportionately cost-burdened with nearly half of all local renters spending 30 or more of their income on rent. This situation will continue to be exacerbated with the continued and projected growth of our city and affordable housing supply gap (especially for those earning less than 30 AMI). My 100-year-old neighborhood is currently experiencing an increased number of demolitions that further erodes our affordable housing stock as most of these homes are replaced with more expensive single family residences. We rarely find the missing middle housing that our City desperately needs. I find that my role in our neighborhood association is often to educate, engage and advocate against such demolition and for missing middle and affordable housing solutions. My role with the Tier 1 Neighborhood Association as its **Director of Legislative Affairs** helps translate some of these

	policy themes into state level action while reviewing proposed legislation that may affect local issues. We have a lot of work to do to catch up with the recommendations in the 2018 San Antonio Housing Policy Framework, especially with a worsened situation brought on by the affects of the ongoing pandemic (with an eviction moratorium expiring in 48- hours).
