Discussion and possible action on SEP-HCP application for the Santikos 26.5-Acre Potranco Road Site (SEP 21-006), generally located off of W Loop 1604 S Access Road, just south of Potranco Road in San Antonio, Bexar County. Monique Mercado, Principal Planner, this project is located within western Bexar County, it consists of approximately 26.5 acres of undeveloped land located off of W Loop 1604 S Access Road, just south of Potranco Road. Santikos Potranco Raw Land, LLC, owner is considering the future development of the Project Area, including buildings, roadways, and associated utilities. This proposed project area includes 0 acres of golden cheeked warbler (GCW) habitat and 0 acres of GCW habitat within 300 feet. There is no black-capped vireo (BCV) habitat and will not require any BCV conservation credits. The Project Area is located entirely over Karst Zone 3 and totals 26.5 acres and is not located within any Critical Habitat Units nor is it within 750-ft of any occupied features.
