Henrietta LaGrange thanked Rudy Orozco, Eric Cervantes, Ramiro Regino, Andrew Aguilar, Christopher Rivera, Federico Vargas, Daniel Ayala and Juan Cruz for their efforts at 2500 W. Mulberry. She stated that the community was exited to see Rudy Garza appointed as Interim CEO of CPS Energy.

Beverly McCall spoke of the concrete blockage of Culebra and Hamilton Streets and requested that it be removed.

Jake Tucker, Rachell Tucker and Jason Anderson of the Party for Socialism and Liberation encouraged each Councilmember to assist one family in their Council District who was in need of housing. He expressed concern that applications for housing assistance were not reviewed in a timely manner.

Denise Alvarez stated that she applied for housing assistance three times and she had received a notice of accelerated foreclosure.

Rosario asked the City Council for help with bills such as electricity and gas.

Alma Hernandez stated that the process for housing assistance was too long.

Emma Divin stated that nearly everyone she had spoken to had not heard of the housing assistance program.
