The City Council convened a regular meeting in the Norma S. Rodriguez Council Chamber in the Municipal Plaza Building beginning at 9:18 AM. Interim City Clerk Debbie Racca-Sittre took the Roll Call noting a quorum with the following Council Members present:

PROCEDURAL

1. The Invocation was delivered by Reverend James P. Amerson, Senior Pastor of Saint Paul United Methodist Church, guest of Councilmember McKee-Rodriguez, District 2.

- 2. Mayor Nirenberg led the Pledge of Allegiance to the Flag of the United States of America.
- 3. Approval of minutes for the City Council meetings of December 1, 2021 and December 2, 2021

Councilmember Rocha Garcia moved to approve the minutes for the City Council Meetings of December 1, 2021 and December 2, 2021. Councilmember Courage seconded the motion. The motion prevailed by the following vote:

Mayor Nirenberg announced that the introductory music played was in honor of Mexican Mariachi music legend Vicente Fernandez who passed away this week.

POINT OF PERSONAL PRIVILEGE

Councilmember Sandoval recognized the work of WellMed who ensured the community had access to COVID-19 vaccines at senior centers. Councilmember Sandoval presented an award to Carol Zernial, Vice President of Social Responsibility, WellMed Charitable Foundation. Zernial stated that many people were vaccinated during this effort. Councilmember Sandoval recognized former City Councilmember Rebecca Viagran who spoke regarding the work performed to get the vaccine to the Southern Sector of San Antonio and to those who were most vulnerable.

Councilmember Rocha Garcia also thanked WellMed and recognized former City Councilmember Shirley Gonzales, Teresa Menendez Myers, Dr. Anita Kurian, and Erik Walsh for their help.

Councilmember Viagran also recognized the work of the Councilwomen and WellMed.

Councilmember Pelaez recognized the work performed by Anwar Tahir with the Association of Convenience Store Retailers, Muhammad Choudary with Mission Wrecker Service, Sarah Shakil with CAARS Inc., Ed Badarpura with the South Texas Merchants Association and all local businesses in Council District 8 to collect food, toys and clothing for refugees.

CONSENT AGENDA

Mayor Nirenberg stated that Items 4, 21, 24, 32, 37, 45 and 46 were pulled for individual consideration.

Mayor Nirenberg called upon the individuals registered to speak on Consent Agenda Items.

Debra Omowale Jarmon, CEO and Director of the San Antonio African American Community Archives and Museum spoke in support of Item 16.

Corina Castillo-Johnson spoke in support of Item 16.

Matt Brown, CEO of Centro San Antonio spoke in support of Items 16, 17, 40, 43 and 44 and the

utilization of TIRZ and Bond funding to invest in downtown San Antonio.

David Mahaffey, former Bexar County Commissioner for Emergency Services District 5 spoke in opposition to Item 45.

Councilmember Castillo highlighted and provided her support for Item 20.

Councilmember Viagran highlighted Item 23 and stated that this was an important Item to Seniors.

Councilmember Viagran highlighted Items 25 and 26 and thanked the Board Appointees from Council District 3.

Councilmember Bravo announced that Item 33, Resolution to initiate historic landmark designation for the property at 503 Urban Loop had been postponed to February 17, 2022.

Councilmember Rocha Garcia highlighted Item 13 and expressed that she was pleased to see the improvements at the Council District 4 Heritage Community Center.

Councilmember Cabello Havrda highlighted Item 27 and thanked the Board Appointees from Council District 6.

Councilmember Sandoval highlighted Item 42 and expressed her support for the Interlocal Agreement with STRAC.

Councilmember Sandoval highlighted Item 15 and thanked staff for their assistance providing services to Council District 7 residents while the Forest Hills Library was closed for repairs.

Councilmember Courage highlighted Item 45 and thanked the Board Appointees from Council District 9.

Councilmember Rocha Garcia highlighted Item 30 and offered her support of the Hazard Mitigation Plan.

ACTION ITEMS FOR STAFF BRIEFING

Mayor Nirenberg called on individuals registered to speak on Item 4.

Peter Onofre, Council District 4 Representative on the Housing Bond Committee, spoke in support of Item 4 except for the continuation and subsidization of the current public housing model which he stated should be improved.

Melanie Cawthon, a stakeholder who attended SHIP development meetings, spoke in support of Item 4 as accessible affordable housing was included in the Plan.

Brad McMurray, Vice President of Property Development for Prospera Housing Community Services, described the work of his company and spoke in support of Item 4.

Cynthia Spielman, a stakeholder who attended SHIP development meetings, noted that the community engagement process could have been more inclusive, and the lengthy Plan was difficult for citizens to review and provide input on. Spielman requested that City Council delay their vote on Item 4 to allow for more community input.

Blanca Perez spoke in support of Item 4 and requested specific support of the goals of affordable new homeownership in the Plan and commended the work of Habitat for Humanity.

Habitat for Humanity spoke as a group represented by President Natalie Griffith, Vice-President of Program Development Michael Taylor, and Volunteer Timothy Payne spoke in support of Item 4, specifically the goals of new homeownership and recognized a group of community advocates who supported the SHIP.

Grace Rose, past president of Keystone Neighborhood Association, representing the Tier 1 Neighborhood Coalition requested more time for the community to provide input on the SHIP.

The Mayor's Housing Commission spoke as a group represented by Former City Councilmember and Commission Chair Shirley Gonzales, President of Merced Housing and Commissioner Kristen Davila, and Merced Housing Operations Assistant Elisa Beckmann in support of the SHIP.

4. 2021-12-16-0961

Ordinance approving the City's Strategic Housing Implementation Plan (SHIP). [Lori Houston, Assistant City Manager; Verónica R. Soto, Director, Neighborhood and Housing Services]

Assistant City Manager Lori Houston presented an overview of the Strategic Housing Implementation Plan (SHIP) and reported that 12 of the 24 strategies had been completed. Houston described the community input process, the work of partners and the Housing Commission, and recommended that the SHIP be adopted by City Council.

Ian Benavidez, Assistant Director of Neighborhood Housing Services Department, recognized staff, consultants, stakeholders, and partners that worked on the SHIP. Benavidez presented the SHIP background, need, approach, 10-year funding Plan, strategies, public engagement, and next steps for the Plan which followed the Mayor's Housing Policy Framework adopted in September 2018. Benavidez presented recalibrated targets for homeownership and rentals, described programs and methods for tracking implementation and goal achievement. Benavidez outlined the 10-year funding Plan and sources.

Benavidez listed 36 total strategies that fell into five Housing Policy Framework Focus Areas that included: Development of a Coordinated Housing System, Increasing City Investment in Housing, Increasing Affordable Production, Rehabilitation and Preservation of Existing Housing, Protection and Promotion of Neighborhoods, and Ensuring Accountability to the Public. Benavidez emphasized that multiple entities were adopting the SHIP such as the San Antonio Housing Trust, San Antonio Housing Authority, Bexar County and other community partners.

Mayor Nirenberg entered letters of support into the record from the South Alamo Regional Alliance for the Homeless, San Antonio Board of Realtors, Disability SA, Franklin Development Corporation, San Antonio Housing Authority, LISC San Antonio, San Antonio Housing Trust, Housing Consultant Robert C. Flores, and Alamo Architects. Mayor Nirenberg thanked everyone who worked on the SHIP and expressed his support for the Plan that began in August 2017 with the Housing Policy Framework and the Mayor's Task Force.

Councilmember Rocha Garcia highlighted several items and strategies included in the SHIP, noted the extension of community engagement, and spoke in support of the Item. Councilmember Rocha Garcia also reminded everyone that the SHIP could always be amended.

Councilmember Sandoval highlighted several items and strategies included in the SHIP. Councilmember Sandoval asked if the SHIP considered health protective strategies. Benavidez confirmed that they were included and added that health protective strategies would be clarified in the document and included in the Sustainability section.

Councilmember Viagran spoke in support of the Item but stressed that she wanted to ensure that there was a focus on breaking the cycle of poverty and inclusion of wraparound services. Benavidez stated that there was a model for the wraparound services which had not been started.

Councilmember McKee-Rodriguez recognized the demonstrators outside who were focusing on homelessness in San Antonio. Councilmember McKee-Rodriguez called for continued community engagement with an annual check-in. Councilmember McKee-Rodriguez supported redirection of funding in support of housing needs and refusing to allow vulnerable communities to be exploited. Councilmember McKee-Rodriguez added that displacement was an issue in Council District 2 and should be included in the SHIP.

Councilmember McKee-Rodriguez moved to amend the Plan to include language that required displacement studies as a condition during the contract procurement process for projects in areas that had a history of displacement, and that applicants should be provided additional points in their applications for eliminating or significantly reducing displacement.

Councilmember Sandoval supported the amendment but requested more detail be provided to the City Council.

Councilmember Viagran supported the spirit of the amendment but recommended that the amendment be addressed following more public comment.

Councilmember Pelaez supported the spirit of the amendment but noted that he still had questions. Following City Council discussion on the amendment, Councilmember McKee-Rodriguez withdrew his motion.

Discussion continued on the main motion to adopt the SHIP.

Councilmember Courage supported the SHIP and did not recommend changes at the present time, although he noted that the Plan was a living document and could be updated.

Councilmember Pelaez commented on the broad support of the SHIP and expressed his support of Item 4.

Councilmember Castillo expressed support for Item 4 and asked for the Housing Bond Committee recommendations to be reflected in the SHIP and recommended a four-week pause to provide more time for the community to review the Plan.

Discussion on the delay of the vote was held. Councilmember McKee-Rodriguez supported the delay in order to allow citizens to review the SHIP.

Councilmember Sandoval was comfortable approving the SHIP but was concerned about ensuring broader community support. Councilmember Sandoval expressed that some of the new changes made on Monday were rather last minute. Lori Houston acknowledged the comments that had been received and incorporated Monday adding that staff met with the Tier 1 Neighborhood Coalition to go over all changes. Councilmember Sandoval asked a representative from Tier 1 to come forward to provide input on whether the "last minute" changes were substantial. Cynthia Spielman said that she did not meet with staff on Monday, noting that she supported the SHIP but was concerned about public participation principles more than the content of the SHIP.

Councilmember Bravo commended the efforts of citizens who provided input on the SHIP and other City policy discussions. Councilmember Bravo expressed support for delaying the vote on Item 4.

Councilmembers Pelaez and Viagran spoke in opposition to the delay of Item 4.

Councilmember Perry asked Cynthia Spielman to provide information on the Tier 1 Neighborhood Coalition and whether they felt the latest changes were substantial. Spielman stated that Tier 1 was comprised of 50+ downtown neighborhoods (located within Loop 410) but stressed that the changes should be further reviewed even though she did not have any opposition to Plan.

Mayor Nirenberg stated that the SHIP had been under development for 18 months and was a living document that could be molded and shaped along the way but did not support the delay.

Councilmember Castillo moved to Continue until January 13, 2022. Councilmember McKee-Rodriguez seconded the motion. The motion failed by the following vote:

Councilmembers Cabello Havrda spoke in support of approval of the SHIP.

Councilmember Perry spoke in support of the SHIP but stressed that Federal and State Funding should be used prior to City Funds for affordable housing. Councilmember Perry requested that staff continue to record and address comments even after the SHIP was passed. Assistant City Manager Houston stated that comments would be collected per strategy and clarification on the

approval for each strategy would be provided to City Council before approval.

Councilmembers Bravo and McKee-Rodriguez supported Item 4 and offered to collect more feedback as the Plan was implemented.

Councilmember Castillo noted that she would abstain from voting even though she supported the SHIP as she felt it was important to provide more time for community engagement.

Councilmember Rocha Garcia asked for clarification on the source of the comments from community members. Benavidez explained that the comments were from the Justice of the Peace Courts.

Councilmember Pelaez asked if the SHIP could include more coordination with mortgage lenders.

A vote was taken on Councilmember Rocha Garcia's motion to approve. Motion passed with abstention from Councilmember Castillo and Councilmember Sandoval noted as Absent.

Councilmember Sandoval reentered the Council Chambers.

Councilmember Rocha Garcia moved to reconsider the vote to allow Councilmember Sandoval to vote. Councilmember Viagran seconded the motion to reconsider. Motion carried unanimously 11-0.

Councilmember Rocha Garcia moved to approve. Councilmember Viagran seconded the motion. The motion carried by the following vote:

[Roderick Sanchez, Assistant City Manager; Michael Shannon, Director, Development Services]

Michael Shannon, Director of Development Services, provided an overview of the current Noise Ordinance and Building Code and proposed Amendments specific to construction noise which redefined the hours which construction was allowed by shortening them to allow construction between 7:00 AM and 8:00 PM, Monday through Friday; 8:00 AM to 8:00 PM on Saturdays and 9:00 AM to 5:00 PM on Sundays. If the contractor wanted to work outside these hours, they would be required to get an exemption from the Development Services Department.

Shannon reported that off-hour construction activity would require the contractor to provide 72 hours prior written notice to the Homeowner's Association (HOA), Neighborhood Association (NA) or Management Company (MC), and if there were no HOA, NA or MA, required the construction company to directly notify residents within 300 feet of the construction site. Shannon indicated that notification was also required to be posted on the job site that included: dates and times of proposed off-hour construction, and the Contractor's name and contact information for the Project Superintendent. Shannon noted that the policy would also provide for enforcement by the Building Official for violators using a citation, fine, suspension or revocation of the building permit for repeat violations. Shannon added that the Code Amendment provided exceptions for safety for concrete pours, emergency projects, public convenience and government projects.

Councilmember Courage read an excerpt from the book "Goodnight, Goodnight Construction Site" and spoke in support of the Item. Councilmember Courage moved to approve the changes to the City Code as presented by staff. Councilmember McKee-Rodriguez seconded the motion.

Councilmember McKee-Rodriguez noted that there had been conflict between residents and their associated NA as sometimes the NAs did not notify the residents. Councilmember McKee-Rodriguez moved to amend the original motion to require written notification to all occupied residential structures within 300 feet of the construction site and the HOA, NA, or MC, when applicable. Councilmember Castillo seconded the motion.

Councilmember Cabello Havrda asked for clarification of the original motion versus Councilmember McKee-Rodriguez' amendment.

Councilmember Courage explained that his original Council Consideration Request Memo required the construction company to put the notices on the doors of residents within 300 feet of

the construction site, however, after discussions with stakeholders, the requirement was to notify HOA, NA or MA who would then notify the residents instead of the construction contractor having to notify individual residents.

Shannon further explained that for instances where there was not an HOA, NA, or MA, then the direct resident notification such as door hangers would be required as well as the provision of contact for the construction company on the job site.

Councilmember McKee-Rodriguez explained that his amendment was to always require notification directly to the residents even when there was an HOA, NA or MA.

Councilmember Perry asked if the construction industry was supportive of both notifications to residents and the associations. Shannon stated that after two years of discussions contractors wanted to coordinate with the organizations, if they existed, instead of placing door hangers especially for apartment complexes and gated communities. Councilmember Perry did not support the amendment and remarked that it was not worked out with the construction community.

Councilmember Sandoval asked for clarification on the requirement proposed by staff. Shannon explained that the program required door hangers if there was not an HOA, NA or MC but there was an additional requirement for notification to be posted on the construction site with a phone number for the site superintendent to take complaints. Councilmember Sandoval expressed concern that requirements might be onerous to NA's and they should have had input.

Councilmember Viagran expressed support for the amendment.

Councilmember Pelaez suggested MC's were often non-responsive and did not always do the best job of getting the word out to residents. Councilmember Pelaez was concerned about how gated communities could be accessed for door hangers.

Councilmember McKee-Rodriguez was concerned that there had not be representation of Council District 2 NAs in the communication.
