

Project Overview

The Transportation Department is seeking a qualified consultant to assist in updating the City's Bicycle Network Plan. This plan will identify and prioritize bicycle and non-motorized network improvements based on existing conditions, existing and future plans, newly identified priorities, and the ongoing needs of people riding a bicycle for any trip purpose.

- Updating the 2011 Bicycle Master Plan
- Existing bicycle gaps needing improvements and prioritization
- Currently a Bronze level Bicycle Friendly City (League of American Bicyclists)
- Equity, visibility, and quality opportunities



Goals of Bike Network Plan

The Transportation Department is seeking qualified Consultants to complete a comprehensive update of the 2011 Bicycle Master Plan.

Primary Objectives:

- Assess current state of the bicycle environment in San Antonio and present an evaluation of common barriers to entry
- Comprehensive and sustainable bicycle network that allows every resident access to safe and comfortable bicycle facilities
- Establish performance metrics to support the City's equity, sustainability, and economic development goals
- Analyze the impact of the bicycle network on the health of San Antonians
- Provide a funding strategy for the implementation of the bicycle infrastructure network over the next 10 years
