## 2. Briefing and Update on Ongoing 2022 Bond Program Process

Mr. Homer Garcia III, Parks and Recreation Director provided a briefing on the status of the 2022 Bond Program. Mr. Garcia highlighted that the 2022 Bond Program is proposed at \$1.2 Billion across several propositions including \$274 Million for Parks, Recreation, and Open Spaces for 67 projects, include \$110 Million for the Linear Greenway Trails. Mr. Garcia highlighted the Bond Tri-Chairs and the Proposition Co-Chairs including Jim Bailey and Jeanette Honermann as co-chairs of the Parks, Recreation, and Open Space bond proposition. Mr. Garcia discussed the overall timeline including 4 Bond Committee meetings in November and December, with the Committees presenting their Recommended Lists to City Council on January 12; City Council Approval of Final Project List on February 10; and the public vote for the 2022 Bond Program on May 7.

# 4. Parks and Recreation Director's Report

- Mr. Homer Garcia III, Parks and Recreation Director provided information on General Departmental Updates. Mr. Garcia went over the status of Bikes on Trails, referencing an article on e-bikes and the increased growth of the use of electric bicycles and how the trail system is becoming a form of transportation. Mr. Garcia highlighted that a new Texas State law allows electric bikes on trails and our local ordinance has not caught up with new State law but confirmed that e-bikes are allowed on city trails. Additionally, Mr. Garcia referenced a recent Department Trail Use Survey that asked about safety on the trails in regard to speed limits and that there are speed limits on the trails and the Department is currently working with Park Police for enforcement, as applicable, and better signage.
- Mr. Garcia stated that the Parks and Recreation Department has increased hiring and the process for posting available positions has been streamline, which expedites the hiring of these positions.

• Mrs. Nikki Ramos, Parks and Recreation Assistant Director highlighted upcoming events including *"Swim with the Elves"* at the San Antonio Natatorium and Winter Holiday Camp held at 18 Community Centers.
