#### **BACKGROUND INFORMATION:**

Applications for appointments to a board were submitted to the Office of the City Clerk who coordinated review of the applications with the pertinent City Department and the City Attorney's Office. The applications of qualified applicants were forwarded to the respective Council Office for review. A memorandum designating an appointee was submitted to the Office of the City Clerk for processing.

The Transportation and Mobility Council Committee convened on October 19, 2021 and heard brief statements from five of the seven selected applicants for the Business Category, after two of the selected applicants declined to be interviewed. The Committee approved the Motion to move forward with three of the five candidates, Marsha Hendler, Francisco Cruz, and Matthew Starr for consideration along with the recommended slate of Airport Advisory Commission members for 18 of the 19 available slots for consideration at the November 16, 2021 meeting.

The Transportation and Mobility Council Committee convened on November 16, 2021 and approved the Motion to recommend and forward three of the five candidates for the Business Category, Marsha Hendler, Francisco Cruz, and Matthew Starr, along with the recommended slate of Airport Advisory Commission members for City Council consideration at the December 2, 2021 A Session.
