Portable Basketball Floor for the Alamodome

#### **SUMMARY:**

This ordinance authorizes a contract with Connor Sports to provide and replace the existing portable floor system and provide a new and safe structure for future events and sports that will utilize the basketball floor at the Alamodome for a total cost of \$180,558.00 for the Convention and Sports Facilities Department. This ordinance appropriates funding for this purchase through the FY 2022 HOT Redemption & Capital Fund.

# **BACKGROUND INFORMATION:**

Submitted for City Council consideration and action is an offer from Connor Sports to provide the Convention and Sports Facilities Department with a contract to replace the existing portable floor system with a new and safe floor system for future events and sports that will utilize the basketball floor at the Alamodome. This portable basketball floor system is procured through Connor Sports' cooperative agreement with Sourcewell (#060518-CSC-1).

The current portable floor system in the Alamodome is displaying wear and tear due to usage, thus having surpassed its useful life. To maintain proper safety for use, it is necessary that the existing

flooring be replaced. To minimize the lead time for replacement and to ensure a new flooring is in place for use, the Convention and Sports Facilities Department recommends a like for like replacement. To this end, the Convention and Sports Facilities Department secured an offer from Connor Sports.

### **ISSUE:**

This contract with Connor Sports will provide the Alamodome with a contract for a replacement portable basketball floor system. Due to wear and tear and age over time, the structure is necessary for replacement. The contractor will provide delivery and materials necessary for the proper execution of this contract. Connor Sports warrants the new portable floor system with a one (1) year warranty on parts and materials.

This purchase of the portable floor system will utilize the Sourcewell Contract # 060518-CSC-1 and will be made in accordance with the National Joint Powers Alliance (Sourcewell) Cooperative Program passed on Ordinance 2009-02-12-0102, dated 2/12/09. Contracts awarded through the Sourcewell Purchasing Cooperative are competitively procured and meet all bidding requirements.

The Small Business Economic Development Advocacy (SBEDA) Ordinance requirements were not applied due to the lack of small, minority, and/or women owned businesses available to provide these goods and services.

The recommended award is an exception to the Local Preference Program.

The Veteran-Owned Business Program does not apply to good/supplies contracts, so no preference was applied to this contract.

### **ALTERNATIVES:**

Should this contract not be approved, the Convention and Sports Facilities Department would not be able to secure one of the limited production slots for this purchase in which Connor Sports would build in October 2022 for a December 2022 delivery, and the Alamodome would not have the ability to provide the appropriate basketball flooring to host future games such as the UIL State Tournament for the community.

### **FISCAL IMPACT:**

This ordinance authorizes the purchase of a replacement portable floor system for the Alamodome for a total cost of \$180,558.00. This ordinance appropriates funding in the amount of \$180,558.00 for this purchase from the FY 2022 HOT Redemption & Capital Fund.

## **RECOMMENDATION:**

Staff recommends the approval of this purchase and offer from Connor Sports to provide the Convention and Sports Facilities Department with a new quicklock fusion portable basketball floor system for the Alamodome for a total cost of \$180,558.00.

This contract is procured by means of cooperative purchasing and a Contracts Disclosure Form is not required.
