SUBJECT:

Emma Tenayuca Memorial Designation

SUMMARY:

Memorial Street Designation for Emma Tenayuca Memorial Way (Council Districts D1 and 5): An ordinance authorizing the Memorial Street Designation of East and West Cevallos to reflect Emma Tenayuca Memorial Way, between IH-35 and Probandt Street.and the remaining \$3,000 will reimburse the General Fund for expenses incurred by Public Works related to the signage.

BACKGROUND INFORMATION:

The memorial designation honors the memory and accomplishments of Mexican American Civil Rights activist Emma Tenayuca.

Analysis and Notification Process:

This memorial designation was processed in accordance with Chapter 6 Section 672(d)(2), which allows designations for memorials to national or state leaders or public figures.

This memorial designation will require zero (0) address changes.

The segment consists of approximately four (4) memorial designation signs.

Inter-Departmental Technical Review:

All City Departments reviewed the proposed request in accordance with Chapter 6 Section 675 of the City Code. The technical review included:

Development Services Department received no concerns from any reviewing agency.

Historic and Design Review Commission Public Hearing:

The Historic and Design Review Commission recommended approval of this memorial designation on Wednesday December 21, 2022.

Planning Commission Public Hearing:

71 Notices were mailed to property owners along the segment of road affected by the memorial designation. The Collins Gardens Neighborhood Association and the Lonestar Neighborhood Association were both notified of this memorial designation proposal.

Additionally, a community meeting was held at the Development Services OneStop on December 15, 2022.

ISSUE:

Approval of this memorial designation will require zero (0) address changes as this request is for a memorial designation only.

ALTERNATIVES:

Denial of this request will result in no changes to any address currently issued.

FISCAL IMPACT:

This ordinance authorizes the one-time funding in the amount of \$4,328.00 of which \$2,164.00 will come from the Mayor's Office General Fund Budget and \$2,164.00 from the City Council District 5 General Fund budget for the application fee of \$1,000.00, notification fees totaling \$328.50, and sign costs of \$3,000.00 associated with the Memorial Street Designation for Emma Tenayuca Memorial Way. Of the \$4,328.00, \$1,328.50 will be deposited to the Development Services Fund.
