Director to report updates on Neighborhood and Housing Services Department Programs

SUMMARY:

Each month the Director prepares a report on program updates directly affecting the Housing Commission and its charge.

BACKGROUND INFORMATION:

Director's Report: (a) Property Tax Help Campaign Update; (b) Tenant's Rights Campaign Update; (c) Housing Assistance Program Update; (d) Bond Funding Round Updates; (e) Application Reminder; (f) Upcoming meetings.

ISSUE:

a) Property Tax Help Campaign (PTHC)

The City's Property Tax Help Campaign helped homeowners file for homestead exemptions and learn about how to protest their property tax valuations. NHSD partnered with Texas RioGrande Legal Aid (TRLA) and San Antonio Legal Services Association (SALSA) to help facilitate and provide free legal services to homeowners seeking assistance. Other resources, including the Bexar County Tax Assessor's Office, were available.

The Campaign included 14 public sessions, from February 13 – May 8, throughout the City with onsite American Sign Language and Spanish interpretation services. One of the sessions was held entirely in Spanish. Information about protesting property taxes and filing exemptions can be viewed online. b) Tenants' Rights Campaign

On May 4, 2023, the City Council approved a Resolution supporting Tenants' Rights and Responsibilities as part of a collaborative effort to raise awareness about fair housing laws, tenant protections afforded by existing local, state, and federal laws, as well as tenant and rental housing provider responsibilities. This Resolution also updated the Notice of Tenants' Rights, which rental housing providers are required to provide to tenants when delivering a Notice to Vacate for non-payment of rent. NHSD staff is continuing to work with our community partners and industry stakeholders to distribute the campaign materials and educational information.

c) Housing Assistance Program

The Housing Assistance Program (HAP) offers temporary rental and utility assistance to help ensure housing stability through times of crisis. Since October 1, 2022, the City has awarded \$5.7 million to 2,136 eligible families. While the demand for housing stability services remains high, the City leverages funds from a variety of state, federal and local sources including a new Treasury reallocation of \$5.2 million to be utilized for HAP's rental assistance program. The City's rental assistance application period is open from May 15- June 5, 2023.

d) Bond Funding Round Follow-Up

The Housing Commission requested staff follow-up with the action taken by City Council related to Housing Bond funding rounds including the names and affordability levels of the projects awarded.

In December 2022, City Council awarded one round of funding for \$43,853,447 made available from Bond, CDBG, HOME, and NSP funding sources and will provide for the development of 14 projects totaling 2,532 total units of which 834 of the units produced or preserved (or 33%) will be deeply affordable units reserved for families below 50% of the Area Median Income (AMI) for rental and below 80% AMI for homeownership. Of all homes, a total of 552 units will be public housing/income-based housing.

In April 2023, City Council awarded \$23,087,158 that was made available from Bond and Federal Home-ARP. The remaining funds were provided from Bexar County Coronavirus State and Local Fiscal Recovery Funds (SLRF) and HOME-ARP in the amount of \$8,162,842. Awards were made to three projects.

e) Application Reminder
